# Showing Up workshop series

A workshop series to support reunification.

## Overview

This workshop series equips parents with vital knowledge and tools to support navigation of the DCP, legal system and access visits in a safe and understanding environment.

## Specifications

- 4 x 2 hour sessions
- morning tea included
- all materials and take home resources supplied.
- max 12 participants/ workshop

## Goals

1. To increase parent understanding, awareness and engagement with the legal rulings and Department expectations required for reunification;
2. To increase parent capacity, communication and collaboration with DCP;
3. To empower parents to identify and actively change what they are able to change and to positively manage what they cannot change.

## Key Outcomes

Parents will leave:

- equipped with practical tools to manage themselves and the requirements outlined in their individual Case Plans;
- having had their questions heard and answered by professionals and others going through, or having successfully navigated the process;
- connected to appropriate services and a safe network;
- reflected on their situation in a safe and supportive environment, connecting with how things look from their child's perspective and empowered to make change.

# Workshop Pragmatics



## Target Audience

The workshop has two modes in single gender contexts:

1. parents with children on Assessment or Reunification Orders.
2. parents with children on Safety Plans.

## Measures and Principles



The Reily Foundation is committed to measureable outcomes that reflect genuine, relevant success. ## Guiding Research

- Parental engagement with services and the legal process is directly correlated with successful outcomes in parent-child relationships and reunification potential.
- Engagement is dependent on not only the internal skills and abilities of the parent but also external determinants such as circumstances, support, resources and the skills of social workers and therapists involved in the process and the relationship they have with the parent.
- An understanding of what an individual can and cannot control or change is linked to effective parent engagement and motivation.
- The compromising impact of stress on both self-regulation and executive functioning, which have been shown to be linked, means that engaging and building capacity in both areas should have a positive impact on parent ability to engage calmly and positively in case plan implementation.
- Utilising lived experience and a collaborative approach has been shown to maximise learning outcomes.
