Communique November 2024

Update

The Direct Experience Group (DEG) held its 5th formal meeting on the 18th November 2024.

Information from the meeting

The meeting was chaired by DEG Chairperson Hayley Brown and nine out of ten core members were in attendance.

A significant focus of the meeting was receiving a report back on recommendations provided so far directly from the Minister for Child Protection Hon Katrine Hildyard who attended for part of the day. The Minister also offered her priority focus areas to assist the development of DEG's 2025 workplan.

In addition, DEG members worked to finalise 2024 workplan areas Topic Area #3 Accountability and Transparency and commence Topic #4 Access to information, advocacy and parenting/ family support.

Preparation activities prior to meeting included:

- Collating of Direct Experience Insights
- Review of Child and Young Person's Safety Ac (2017) available DCP policy and practice documents
- Basic review of the Child and Young Person Safety (and Support) Bill 2024
- Developing understanding of key problem areas and impact
- Defining change needed
- · Development of Theory of Change

Minister Hildyard expressed her deep appreciation for the hard work, considered recommendations and personal commitment made by DEG members throughout 2024.

Minister Hildyard pointed to the Statement of Commitment to Parents and Families, included in the draft legislation as one of the most tangible outcomes of DEG advice.

Hildyard acknowledged that in the time she had with DEG at the meeting, she would not be going through each recommendation made by DEG in 2024. Instead, and on speaking about ongoing reform, Minister Hildyard acknowledged the influence of DEG as part of all her advisory groups. She stated DEG's insights and ideas are considered along with the information coming from young people in the care system, feedback from the 2023 Child Protection and Family Support Symposium and the response to draft Child and Young Person Safety (and Support) Bill 2024.

Hildyard reaffirmed her commitment to listening to parents, family members and others with direct experience of the Child Protection and Family Support system. She encouraged further sharing of lived experience examples in how DEG frame the need for their recommendations.

Questions and discussion with the Minister and DEG covered:

- Improving rooms for better family access.
- Building partnerships with families
- What therapeutic support can be given to children and families separated by the system. Including children whose siblings are in out of home care and kinship carers.
- Utilising Family Group Conferencing for more families, and for different reasons.
- Lived experience input into training for other key stakeholders including DCP staff and Foster Carers

Findings and Recommendations, regarding *Accountability and Transparency* and *Access to information, advocacy and parenting/ family support* and the *2025 Work Plan* will be presented to the Minister for Child Protection in January 2025.
